## Anti-BullyingPolicy

The school recognises that a bullying incident should be treated as a child protection concern when there is reasonable cause to believe that a child is suffering or likely to suffer significant **Starfhare** aware of the need to be extra vigilant and alert to pupils who may be vulnerable or at risk of bullyithgose that fall under

Cyberbullying may be defined as 'the use of electronic communication, particularly mobile phones and the internet, to bully a person, typically by sending message intimidating or threatening nature: children and adults may be reluctant to admit to being the victims of cyberbullying'. It can take a number of different forms: threats and intimidation, harassment or 'cybestalking' (e.g. repeatedly sending usinted texts or instant messages), vilification/defamation, exclusion/peer rejection, impersonation, unauthorised publication of private information/images and 'trolling' (abusing the internet to provoke or offend others o) rained radicalisation. It can be an extension of factor-face bullying, with technology providing the bully th another route to harass their target.

However it differs from other forms of bullying in several significant ways:

- x by facilitating a far more extreme invasion of personal space. Cyberbullying can take place at any time and intrude into spaces that have previously been regarded as safe and personal.

- x promoting and expecting positive respectfulationships between staff and pupils and older and younger pupils based on mutual respect and trust
- x creating an inclusive environment and a school which builds on positiveirsative and commends appropriate behavior in all areas
- x ensuring staff are trained on how to watch for signs, react to and deal with instances of bullying or suspected bullyingStaff need to be particularly alert to pupils who may be vulnerable or at risk from bullying.Training will be given to staff on the needs of our pupils indicate the second educational needs or disabilities
- x Understanding that although bullying is defined as repeated unkindness, the school will follow up ALL incident of unkindness, using the guidelines fium the 'Dealing with a pastoral incident' document.
